2.3.2 – Students mentoring system available in the institution? Give details. (maximum 500 words)

A student coming from the average background and entering the Sanskrit university may feel as if he has entered an alien landscape. He is often confused about various aspects of institution as well as his academic life. Moreover, the university has a sizeable number of students residing in hostels. Being away from home for the first time in their lives may be a traumatic experience for the young students. They may also be exposed to the various dangers and corrupting influences due to the new-found freedom. All this necessitates a close monitoring and emotional support system and to meet this requirement, the university has a well-established mentoring system. The students are divided into manageable groups and entrusted to the care of an experience and considerate teacher who can provide a sympathetic ear and expert advice in both academic and personal matters. Generally, the teacher is the class teacher who has a greater rapport with the students. The mentees can also seed personal support from their mentors as sometimes they cannot share their problems in such matters with their family members or friends. The mentors try to resolve the situation in the best possible way, by winning the trust of the students under their mentorship and using their good offices as well as academic and psychological experience. This year, due to the lockdowns brought on to manage Corona infection, the educational institutions including the universities were closed, and work from home was started. So the routine mentorship programme was thrown off-gear.

a) Laboratory All the campuses of the University have centralized computer labs, language labs and psychology labs and technical labs. All the computer labs have wifi connection and are internet enabled. Timely payment of Wi-Fi bills is ensured to enable 24/7 operationality. Computers, related peripherals

and other gadgets kept in fully functional condition by timely repair and maintenance. The Lab in-charge keeps the Records of the maintenance of laboratory equipment, under the supervision of the Head of the concerned Department. The students are allowed inside the labs only when the concerned teacher in present in the lab. They are not allowed to enter the lab or conduct experiments in lab in the absence of the concerned teacher. In the present academic session, all educational institutions including the University were closed down to control the spread of Corona virus, as a result of which no laboratory work was conducted. b) Computers Besides Computer labs, computers have been provided in the offices of the Principal, Heads of the Departments, administration section, finance section and staff rooms. These computers are used by the teaching and non-teaching staff for office work and for preparing teaching material by the teachers. Besides yearly inspection and repair, the computers and their peripherals are maintained and repaired as and when required. This year, as all the educational institutions were closed to tackle the Covid menace, the repair and maintenance of the computers could not take place. c) Library Books for the Central Library, Campus Libraries and Departmental Libraries are procured as per the recommendations of the concerned library committees. The Library committees invite suggestions / requirement from the teachers and make recommendations to the respective Principals taking into consideration the available funds and urgency of the requirement. The students and research scholars may borrow 2 and 3 books respectively for 15 days. After that, the borrowings may be renewed depending upon the availability of the copies of the book and demand by other users. d) Sports Complex There is no dedicated sports complex as such, but various campuses have gyms and indoor games facilities for the use by the students and teachers under the supervision of sports teacher. The Staff residing at the campus and the Hostel inmates make the optimum use of these facilities. The maintenance of sports and gym equipment in these facilities is carried out as per the report of the sports teacher and the recommendation of the sports committee. In the present academic session, all the sporting activities were suspended. e) Classrooms The classrooms are routinely inspected by the campus authorities such as the Principal and the concerned committees. In case, some repair work is needed, appropriate measures are taken by the administration. Repairs of the furniture and other fixtures are generally carried out during the summer breaks so that the class work is not affected. In the present academic session, all the academic activities were suspended, due to closure of academic institutions as per the government orders and some of the above activities

8. Future Plans of Actions for Next Academic Year

Future Plans of Action for Next Academic year Using online resources Going by the experience of survival in Covid times, it was realized that online mode of instruction and education is here to stay even after the epidemic threat recedes. It was also realized that many of the teachers were feeling at sea when it came to using online platforms for giving online class instructions. Hence, it becomes imperative that the teachers should be well-versed in use of online resources. Therefore, it was decided that special workshops should be conducted to train the teachers of the university in the use of preparing ppt presentations, classroom lectures, video lectures, conducting online classes, using social platforms like Facebook and Whatsapp for conducting classes, storing academic data on google drive and providing ling therefrom, etc. Record-keeping during Covid times During Covid times, the teachers are also expected to keep records of their classroom activities and evaluation activities. For the purpose, various tools like Google forms etc. are available but the older generation of teachers is more or less unaware of them. In view of this, the university shall be conducting workshops to train teachers in use of these technologies which can be used for conducting online objective-type tests for the students. This would not only make it easy for the teachers to give test-papers to their students, but would also provide the facility of automatic evaluation of the students' responses. Arranging for online communication tools like Zoom and Google meet It was realized that sometimes number of persons wishing to join an online meeting exceeds the free limit allowed by the platforms like Zoom and Google meet. So, arrangements shall be made for the campuses to subscribe to the paid services of these platforms so that not only they can extend invitation to 250 persons but also record the meetings for future reference. This would also go a long way in providing support material when going for NAAC accreditation.
